

**MONDİ TURKEY OLUKLU MUKAVVA KAĞIT VE AMBALAJ SANAYİ
ANONİM ŞİRKETİ
DATA SUBJECT APPLICATION FORM**

1. General Information on Your Right to Application

In accordance with Article 11 of 6698 numbered Personal Data Protection Law (“**Law No. 6698**”), you may apply to Mondi Turkey Oluklu Mukavva Kağıt ve Ambalaj Sanayi Anonim Şirketi (“**Company**”) as a data subject and make the following requests:

- (1) To learn whether your personal data are being processed,
- (2) To request information if your personal data have been processed,
- (3) To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- (4) To learn which third parties domestic or abroad your personal data has been transferred to,
- (5) To request rectification in case your personal data has been processed incompletely or inaccurately and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- (6) To demand the erasure or destruction of your personal data in the event that the reasons for the processing no longer exist even though it was processed in accordance with the Law No 6698 and other relevant provisions and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- (7) To object to negative consequences to you that are concluded, as a result of analysis of the processed personal data through solely automatic systems,
- (8) To demand compensation for the damages that you have suffered as a result of an unlawful processing of your personal data.

In accordance with Article 13 of Law No. 6698, depending on the nature of the request, our Company will conclude your application as soon as possible and within thirty (30) days at the latest.

2. Application Method

You may convey your requests within the scope of your rights herein to our Company in writing or by using your registered electronic mail (KEP) address, secure electronic signature, mobile signature, or your e-mail address that you have previously notified to our Company and registered in our system in accordance with Article 13 of the Law No. 6698 and Article 5 of the Communiqué on the Principles and Procedures for the Request to the Data Controller.

The following explanations regarding the written application channels should be paid attention to during the application by the Data Subject.
